- · Every time a new associate joins your business builder team by purchasing a qualifying enrollment pack, Business Builder Bonuses are paid. The bonus is equal to 20% of the commissionable volume of the qualifying purchase.

The Preferred Customer Bonus and Business Builder Bonus will be generated on the commission run following qualifying registrations and will be paid as part of your regular commission check.

FAST 4WARD CHALLENGE RULES

ELIGIBLE PARTICIPANTS

Associates in any open ASEA market can participate in Fast 4ward and Fast 4ward Plus.

STARTING THE FAST 4WARD CHALLENGE

To start your Fast 4ward challenge, visit your ASEA virtual office, click on the Fast 4ward banner, and follow the prompts to begin your 14-day challenge period. Once you begin your challenge, you can't pause or restart. You have 14 days to complete the challenge.

You can complete as many Fast 4ward challenges as you want, beginning a new one every 14 days. You may start your next Fast 4ward challenge the day after the current challenge runs its full 14 days. The cycles cannot overlap.

You may start your Fast 4ward challenge any day of the week. You may choose the current date or back-date your opt-in by up to 72 hours, allowing you to count preferred customers or associates who have recently joined. Your start date may not overlap your current Fast 4ward challenge with a previous Fast 4ward challenge.

CHALLENGE REQUIREMENTS

Within your 14-day challenge period, you must:

- Grow your business by registering a minimum of four new preferred customers with your customer base or new associates with your team of business builders, each with a minimum first order of 100 promo points and a minimum 100 promo-point subscription.
- Achieve a minimum cumulative 800 promo points from new first order volume.
- Subscriptions must successfully process within 60 days of enrollment.

You can go for more rewards with the Fast 4ward Plus challenge, which gives you 14 days to:

- Grow your business by registering a minimum of eight new preferred customers with your customer base or new associates with your team of business builders, each with a minimum first order of 100 promo points and a minimum 100 promo-point subscription.
- Achieve a minimum cumulative 1200 promo points from new first order volume.
- Subscriptions must successfully process within 60 days of enrollment.

All preferred customers and associates with qualifying first orders on or after the calendar day you start your Fast 4ward challenge and all first order PV tied to those new clients will count toward your Fast 4ward qualification.

Promo points are valued at 1 PV = 2 promo points for preferred customers; 1 PV = 1 promo point for associates.

FAST 4WARD REWARDS

Each successful Fast 4ward challenge completed earns you a Fast 4ward reward.

Fast 4ward rewards include:

Fast 4ward Plus rewards include:

- 25 RENU28® samples
- 327.60 Redox Rewards points

If you are in the middle of a Fast 4ward Plus challenge and enrolled 8 new associates or preferred customers, but only 4–7 of those have a successful subscription within 60 days, you will not qualify for the Fast 4ward Plus rewards (327.60 Redox Rewards points) but you will still qualify for the Fast 4ward rewards (109.20 Redox Rewards points).

REDEEMING YOUR FAST 4WARD AND FAST 4WARD PLUS REWARDS

Once you successfully complete a Fast 4ward challenge, the RENU28® samples will be available in your personal shopping cart. You will have 14 days to redeem them. You are responsible for shipping and handling.

The samples are nonrefundable, and replacements are only available when proof of damage is submitted and approved through the ASEA Associate Support department. Any damage reports must be submitted within five business days of receipt of order.

Redox Rewards points will be credited to your account as soon as the enrollee subscriptions successfully go through within 60 days.
